Commissioners' Reports

- NCSL: Issues: Increase number of teams to be disqualified each season due to long wait list up to 5 teams per age group per season (currently 3 teams per age group per season), billing process, and State Cup registration.
- Girls: 21 girls teams in ATSC between WAGS (10) and ODSL (11). WAGS pre-season meeting March 20. Reminders: need to bring rosters and players' cards to all matches.
- ODSL: ODSL pre-season meeting March 20: discussion of new coach and player development initiatives; May 17: ODSL night at Washington Freedom and DC United game; non-enforcement of sleeveless jersey rule.

Treasurer's Report

2003-2004 Budget Considerations:

- Total cash on hand as of 3/19/03 is \$35,890.08. Anticipated income in spring 2003 is expected at \$11,347 and known expenses are at \$3,642.50. Additional spring 2003 expenses are budgeted at \$23,138. The Treasurer proposed that funding for scholarships be increased to \$10,000 (from initial budget of \$6,000) and funding for coaches licenses courses be increased to \$3,000 (from initial budget of \$1,500), bringing expected spring 2003 expenses to \$28,138. If approved, this would bring net carryover to fall 2003 season to \$15,636.58.
- The Treasurer's recommendations were accepted and the recommended budget approved

DC United

Ryland Dennis: Urged ATSC to take advantage of opportunity of being close to MLS team.

Fields and Equipment

- Gunston Bubble petition: to persuade County to re-build this valuable in-door facility.
- County considering a second synthetic surface field.
- Five kickback goals available for use/distribution.
- Field Set up: teams put up nets on Saturdays, County takes down on Sunday evenings
- Fields:
 - o Not using TJ Upper this season, to be repaired this summer.

Tryouts

- ATSC Policy: required for all players in rising u-12 and younger.
- Tryouts to be mostly small-sided games.
